Legal entity identifiers help you identify your company



Since the establishment of the LEI system, a series of global regulatory initiatives have prompted – and in some cases required – market participants to adopt unique Legal Entity Identifiers. GS1 supports the global implementation of the LEI and can help you with obtaining, renewing, transferring and managing your LEI.

September 2008: Wall Street is in a state of shock. The failure of US investment bank, Lehman Brothers, triggers a catastrophic chain reaction which ultimately results in a global financial crisis. One of the causes: a lack of transparency in the market for bilaterally agreed derivatives within extricable business relations.

An important standard for identification

As a consequence of the crisis and in an effort to create more transparency and security for all participants, the Legal Entity Identifier was introduced: a new standard which allows parties to financial transactions to be uniquely identified worldwide. This is obligatory for a wide range of companies, amongst other export-oriented companies and those involved in derivatives trading, e.g. big names in the consumer goods industry, must have an LEI.

GS1 helps you comply with global regulatory requirements

GS1 operates as a Local Operating Unit (LOU) within the Global LEI System (GLEIS), so legal entities from all jurisdictions involved in financial transactions can use the GS1 platform to register for LEIs. GS1 offers a global LEI service, which enables large global organizations with many legal entity subsidiaries and affiliates to register and maintain the reference data for all their entities in a single location. Companies can apply for an LEI via the portal at **www.lei.direct.**

Three easy steps to obtain your LEI (Legal Entity Identifier): Go to www.lei.direct

- 1. Register.
- 2. Apply.
- 3. Receive an LEI.
