CHAIRMAN'S MESSAGE

May, the immediate past chairman, as well as my fellow Board members and the GS1 Hong Kong management team, for their great contributions to making GS1 Hong Kong what it is today.

Barcode, Connecting the Past & Future

On reflection of GS1 Hong Kong's remarkable 35-year journey, I am filled with great pride. GS1 barcode, started as a way to speed up grocery check-out, has since modernized retail and grown into a suite of solutions and services that transform many industries.

Today, our thriving community of over 8,000 members underscores the enduring impact of our standards and collaborative approach.

Recognised by the BBC as "one of the 50 things that made the world economy", GS1 barcode standard has remained just as relevant, as we continue to innovate and introduce 2D barcodes, helping business navigate digital transformation, meet ESG requirements, and satisfy consumer demands for transparency.

Evolving with the Times

The 2D barcode standard gained traction last year, with 26 leaders from some of the world's biggest companies signing a global joint statement, calling for the transition to QR Codes with GS1 Digital Link standard to revolutionise the consumer experience. Signatories included Alibaba.com, AS Watson, Carrefour, IGA, JD.com, JM Smucker, Mondelēz, Lidl, L'Oréal, Nestlé, P&G, etc.

香港貨品編碼協會(GS1 HK)的35周年慶典剛完滿結束，我很榮幸能適逢其會，並成為新一任主席。感謝各位前主席，包括前任主席May、各董事局成員，以及香港貨品編碼協會(GS1 HK)管理團隊的貢獻，為GS1 HK奠定了堅實的基礎，達致今天成就。

條碼 — 延續過去 創新未來

回顧GS1 HK三十五載的非凡歷程，我對於能夠親身見證亦深表自豪。GS1條碼一開始是用來加快結帳速度，其後引領零售業現代化，並發展出一系列方案及服務，為各行業帶來變革。

我們今天能發展出一個8,000多名會員的社群，正好突顯GS1標準和協作方式，持續為社會帶來深遠的影響。GS1條碼被英國廣播公司（BBC）稱為「50件塑造全球經濟事件」之一，至今仍具重要意義。我們銳意創新並推出二維碼，協助企業應對數碼轉型，配合環境、社會和企業管治（ESG）的發展，並回應消費者對透明度的需求。

與時並進

GS1二維碼標準於去年取得重大進展，全球26家跨國巨企的領袖共同簽署了一份全球聯合聲明，呼籲企業轉用加入GS1 Digital Link標準的QR碼，以革新消費者體驗。聯署人包括阿里巴巴、屈臣氏集團、家樂福（Carrefour）、IGA、京東集團、JM Smucker、Mondelēz、Lidl、L'Oréal、雀巢、P&G等。

在本地市場，GS1 HK亦推出了會員免費的「1QR」平台，助企業提升產品透明度，讓消費者只需透過智能手機輕鬆掃描，即可取得大量可靠的產品資訊。品牌可以透過展示證書認證來增強消費者信任及忠誠度、帶動O2O零售、展示可持續發展的承諾、透過掃描活動獲得市場洞見等。

Locally, GS1 HK launched 1QR, a complimentary QR code service for our members, allowing consumers' access to a wealth of trusted information via a simple mobile phone scan. Brands can build confidence and loyalty by showcasing certifications, connect online/offline retail, demonstrate sustainability claims, and gather insights of scan activities.

Extending beyond Hong Kong

GS1 Hong Kong's 2D barcode footprint extends far beyond Hong Kong. Co-leading the China Industrial Internet Identification Resolution Infrastructure project funded by the Chinese authority, we successfully connected our 1QR platform to the infrastructure in China, and interchanged GS1 keys with the Industrial Internet Identifiers. This facilitates product traceability across the cross-border supply chains.

GS1 Hong Kong also took part in the Asian Development Bank-sponsored Carbon Tracking Project, evaluating emissions across Sri Lanka's apparel and textile industry supply chain, from manufacturing to dispatch to European Union's (EU) countries. To prepare for upcoming regulations like the EU's Digital Product Passport, which mandates products to display sustainability data, we helped build a sandbox that used GS1 QR codes to capture and share ESG data, supporting businesses to meet such regulatory requirements.

Continuing Our Innovation Journey

Going forward, innovation will be at the heart of everything we do. Of course, we will face hurdles along the way - the geopolitical tensions, economic decoupling, climate disruptions - but that should not stop us from trying new things and creating exciting ideas.

Through innovations in barcodes, digital trade community platform, smart traceability and sustainability solutions, GS1 Hong Kong will continue to empower companies to 'Go Digital, Go Green' - embracing digital transformation and sustainability.

"Innovation is the spark. Digital Transformation is the flame, and an everlasting journey." I look forward to working with all of our stakeholders as we seek to build on the past successes and forge ahead, which I am certain it will be an exciting, innovative and rewarding journey.

走出香港 跨越界限

GS1 HK的二維碼足跡亦已跨出本港。由內地當局資助、GS1HK有份主導的「粵港工業互聯網標識解析服務」基建項目，成功將GS1 HK的1QR平台與中國基建系統對接，並實現GS1標識與中國工業互聯網標識之間互通。這有助促進由生產、運送到消費者的跨境供應鏈的產品追溯，確保產品高度透明，進一步增強消費者的信任。

此外，GS1HK亦參與亞洲開發銀行（ADB）資助的碳追蹤項目，評估斯里蘭卡服裝和紡織業從生產到出口至歐盟國家整個供應鏈過程中的碳排放量。為配合未來如歐盟數碼產品護照（DPP）等的監管需求，我們協助建立了一個沙盒實驗環境，在供應鏈每個環節獲取並共享ESG數據，並以GS1 QR碼去展示其可持續發展的實證。

延續創新之旅

展望未來，「創新」將繼續為我們領航，為每項計劃倍添價值。前路或許障礙重重 - 地緣政治緊張局勢、經濟脫鉤、氣候突變干擾等 - 但這都無阻我們勇於嘗試、積極創新的熱情。

GS1 Hong Kong將憑藉多元化的創新發展，包括條碼、數碼商貿社群平台、智慧追蹤溯源和可持續發展方案，繼續為企業增添「Go Digital、Go Green」的動力，投入未來數碼轉型及可持續發展。

「創新的火花燃點數碼轉型，照耀生生不息的道路。」我期望與所有持份者昂首闊步，秉承過去的輝煌成就，共同邁向更精彩、創新、豐盛的未來！

The past year marked a key milestone as GS1 Hong Kong celebrated 35 years of history, having empowered business growth and driving industry transformation since 1989. Despite the changing times, our mission has remained

steadfast: to facilitate information connectivity across local, regional, and global supply chains through our extensive portfolio of solutions and services, continually powering the next generation of business, where “Digitalisation”, “Data”, “ESG” will take centre stage.

35 Years Along, Infinite Opportunities Ahead

To commemorate our shared journey, we organised a series of 35th Anniversary activities, inaugurated by our 35th Anniversary Gala Dinner themed “Dazzling Hong Kong”, joined by over 600 guests.

A book named “From Zero to +01” (“從零到+01”) was published to inform and inspire the community and the young, about the significant impact of global standards on Hong Kong’s economy – from the introduction of global barcodes in Hong Kong that revolutionised retail industry, to the development of EDI platform that empowered digital trade, and the enhancement of supply chain management that supported businesses digital transformation.

With an aim to nurture local IoT talents, we organised our first-ever IoT Data Hackathon in collaboration with Cyberport and Hong Kong Science and Technology Park, attracting over 80 teams from universities and industries, and supported by more than 20 mentors and senior executives.

As the host of Healthcare Strategy Roadshow and GS1 Asia Pacific Regional Forum 2024, we welcomed over 150 delegates from GS1 Global & 16 Asia-Pacific economies to share their best practices and regional priorities.

過去一年是香港貨品編碼協會（GS1 HK）成立35週年的里程碑，標誌我們自1989年以來持續為企業推動增長、促進各行業轉型。

時代變遷，但我們的使命始終如一：透過本會多元化的解決方案和服務，促進本地、區域性和全球供應鏈的訊息互聯互通，讓企業躍進新時代、抓緊新商機。

延續三十五載情，共創無限新里程

為紀念本會與業界及商界一直風雨同路、並肩前行，我們舉辦了一系列35週年慶祝活動，先以「璀璨香江」為主題的35週年晚宴揭開序幕，吸引超過600位嘉賓親臨慶賀。

我們同時出版了「從零到+01」書籍，旨在讓普羅大眾和年輕一代了解全球標準對香港經濟的重大影響—從香港引入全球條碼徹底改變零售業，到開發電子數據交換平台促進數碼貿易，以及強化供應鏈管理、支持企業數碼轉型—從而為各界帶來啟發。

為培育本地物聯網人才，我們與數碼港及香港科技園攜手、舉辦首屆「物聯網數據黑客松」（IoT Data Hackathon），吸引超過80支來自大學及業界的隊伍參與，並獲逾20位導師及資深行政人員鼎力支持。

本會作為去年「Healthcare Strategy Roadshow」和GS1亞太區論壇2024的主辦單位，獲超過150位來自GS1全球組織和16個亞太經濟體的代表蒞臨本港聚會交流，討論區內發展項目及最佳實踐案例、相互借鑒。

The GS1 HK Summit 2024 had drawn close to 650 cross-industry delegates from around the region joining in-person, where the first “Digital Transformation Awards” presentation ceremony took place and 23 awards were presented to companies that have successfully implemented digital transformation initiatives.

We have also created an interesting video campaign on NowTV, highlighting the benefits of barcodes & QR codes powered by GS1 to the society, while our anniversary celebrations concluded with a Finale Cocktail attended by hundreds of guests.

Coinciding our anniversary marked the 50th anniversary of the world’s first barcode scan, ushering in a new era underpinned by the emergence of 2D barcodes.

Powering NEXT Generation Business with Digital Product Info

In the ever-changing market characterised by purpose-driven, digitally-savvy consumers, it is essential to meet their expectations on transparency, traceability, and sustainability.

Like our global counterparts, GS1 HK has been accelerating the industry adoption of 2D barcodes, which hold more digital product information than traditional barcodes. We have established “2D Barcode Industry Task Force”, to identify key factors for local adoption and develop a roadmap for implementation at retail points of sale.

Hong Kong companies have been supportive of the initiative. In 2023/24, over 1,500 members are already using GS1 HK’s “1QR”, the 2D barcode built on GS1 Digital Link standard. It enables businesses to effectively communicate product information to consumers while enhancing product visibility and engagement.

To add further value to our members, last year we launched BarcodePlus 3.0, an upgraded version of our product and location data repository. Keeping record of 17.9 million

我們亦製作了一系列有趣貼地的宣傳片於NowTV上播放，講解GS1條碼和二維碼為社會帶來的裨益；數以百計的嘉賓出席誌慶壓軸酒會，為35週年慶劃上完美句號。

適逢本會週年慶是全球首個條碼掃描的50週年，正好標誌著條碼演變進入新紀元。

產品數碼資訊 驅動新世代商業模式

現今消費者大多精通數碼科技、並著重社會價值，企業需滿足他們對產品透明度、可追溯性及可持續性的期望，方能脫穎而出。

GS1HK與全球分會的目標一致，正加速推動業界採用可儲存更多產品數碼資訊的二維碼。本會成立「二維碼行業工作小組」（2D Barcode Industry Task Force），以分析本地持份者的考量及關注，並制訂出零售點應用的路線圖。

本地企業對此倡議一直表現積極支持。在2023/24年度內，約有五分之一本會會員採用了GS1 HK的「1QR」、即加入GS1 Digital Link標準的二維碼。企業以此方案能更有效地向消費者傳達產品資訊，同時增加產品曝光及消費者互動。

此外，我們推出了升級版的產品和位置數據庫BarcodePlus 3.0平台，為企業會員增值。平台記錄1,790萬個產品GTIN，具有新用戶界面、

product GTINs, the portal features a new user interface, simplified data entry and analytics of customer digital footprints on the 1QR platform – providing businesses with actionable insights.

Digital product information is crucial for patient safety too. To track and trace the large volume of pharmaceutical products, the local healthcare authority has confirmed to include the adoption of GS1 DataMatrix (2D Barcode for healthcare) on drug packaging in its new tender document with effect from August 2024. GTIN, batch/lot number, expiration date/best before date are required in the GS1 DataMatrix to fulfil medicine traceability, ultimately ensuring patient safety.

Offering NEXT Level of Data Service

Data is not just the new oil, it fuels innovation and business growth. Our flagship B2B e-commerce community platform ezTRADE, which supports more than 24 million electronic data exchange every year, has been enhanced with additional functionalities that further streamline the trade processes, augmented with a new data warehouse for comprehensive analytics capabilities.

In 2023/24, GS1 Hong Kong continued to serve as the Global Technology Partner of the HK-based, world's largest international health & beauty retailer for enhancing its Supplier Portal solution, and successfully developed a Supplier Portal for one of the largest convenience stores in Hong Kong, to support its communications and management with its supplier community.

Supporting the NEXT Priority on the ESG Agenda

As the HKSAR Government unveils roadmap for sustainability disclosure, companies are preparing to address the more complex Scope 3 requirements. That involves closer collaboration among trading partners to measure, manage and share information about products from their raw material sources through to production, consumption, disposal and beyond.

簡化數據輸入和1QR平台上客戶數碼足跡的分析——為企業提供可付諸實行的分析洞見。

產品數碼資訊對病人安全亦至關重要。為更有效追蹤大量藥品，本地醫療監管機構已確認將於2024年8月起，在其最新藥品招標文件內要求供應商在藥品包裝上採用 GS1 DataMatrix條碼。條碼內需載有GTIN、批次/批號、生效日期/最佳使用日期等資訊，以達致藥品追溯，最終確保病人安全。

提供新一代數據服務

數據不僅是新時代的石油，更是推動創新及業務增長的重要動力。本會B2B電子商務社群平台ezTRADE，每年除支援超過2,400萬次電子數據交換外，現更新增多項功能，進一步精簡貿易流程，並增設全新數據庫，提供更全面的數據分析能力。

於2023/24年度，GS1 Hong Kong繼續擔任總部位於本地、全球最大國際保健及美容零售商的科技合作夥伴，協助其提升供應商平台（Supplier Portal）功能，並為全港其中一家最大的便利店成功開發出供應商平台，支援其與供應商夥伴間的溝通及管理。

助達成下一階段的ESG目標

隨著香港特區政府公佈《香港可持續披露路線圖》，企業正積極準備應對更為複雜的「Scope 3」要求（即機構上下游活動所產生的間接碳排放）。這需要貿易夥伴間共同協作，追蹤及分享產品從原材料來源到消費、廢物處置及其他相關資訊，才可建立可持續供應鏈。

GS1 HK於此扮演重要角色，協助企業達成其ESG目標：

- 開發ESG數據共享方案，助企業管理供應鏈「Scope 3」的數據
- 與行業協會及商業夥伴緊密合作

GS1 plays a vital role in this by enabling businesses to advance their ESG agendas, through:

- Developing ESG data-sharing solutions to support Scope 3 supply chain enablement
- Collaborating with industry associations and business partners
- Providing training, seminars and workshops
- Implementing an ESG recognition scheme and awards

We helped members, including a fast-food restaurant chain and a renowned Italian dessert outlet, in reducing food wastage and ingredient loss by implementing GS1 HK's Smart Operations solution, achieving reductions of up to 10% in food losses along with other cost-savings and more efficient processes.

Our track-and-trace platform ezTRACK provides real-time visibility, laying the groundwork for agile global supply chains while supporting ESG data reporting and sustainability compliance.

We also introduced the "Quality Food Scheme ESG" to recognise companies that provides safer, healthier, and more sustainable food choices, evaluating them based on GS1 Global Traceability Standards, UN Sustainable Development Goals, and MSCI ESG indexes. In its inaugural year, 17 enterprises received accolades for their outstanding ESG practices and commitment to food traceability and safety.

Embarking on our NEXT Chapter

As I reflect on 35 years of innovation and collaboration, I feel deeply honoured to be on this challenging yet rewarding journey together. My deepest gratitude to our members, Board of Directors, Advisory Committee members and partners for the staunch support. Together, we have left a lasting imprint on the business environment, helping businesses grow, evolve, adapt, and thrive.

The years have flown by in the blink of an eye, but a new chapter together has only just begun. Let's strive for a brilliant future for many more years to come!

我們與香港其中一家最大型的公共事業機構合作，監察能源使用情況，識別營運流程中可減少碳足跡的地方。此外，我們亦協助不同會員，包括一家連鎖快餐品牌及一家知名意大利甜品店，透過採用GS1 HK智慧營運方案，減少食品浪費及原料損耗，令食品損耗減少最多達10%，同時降低成本並優化營運效率。

我們的追蹤溯源平台ezTRACK提供實時數據，為達致靈活的全球供應鏈奠定基礎，同時支援ESG數據報告及可持續發展的合規要求。

本會亦推出「優質食品計劃ESG」，表彰提供更安全、更健康、更可持續食品選擇的企業，評估標準涵蓋GS1全球可追溯性標準、聯合國可持續發展目標及MSCI ESG指數。在首屆計劃中，共有17家企業因其卓越的ESG表現，以及對食品可追溯性和安全的承諾而獲得殊榮。

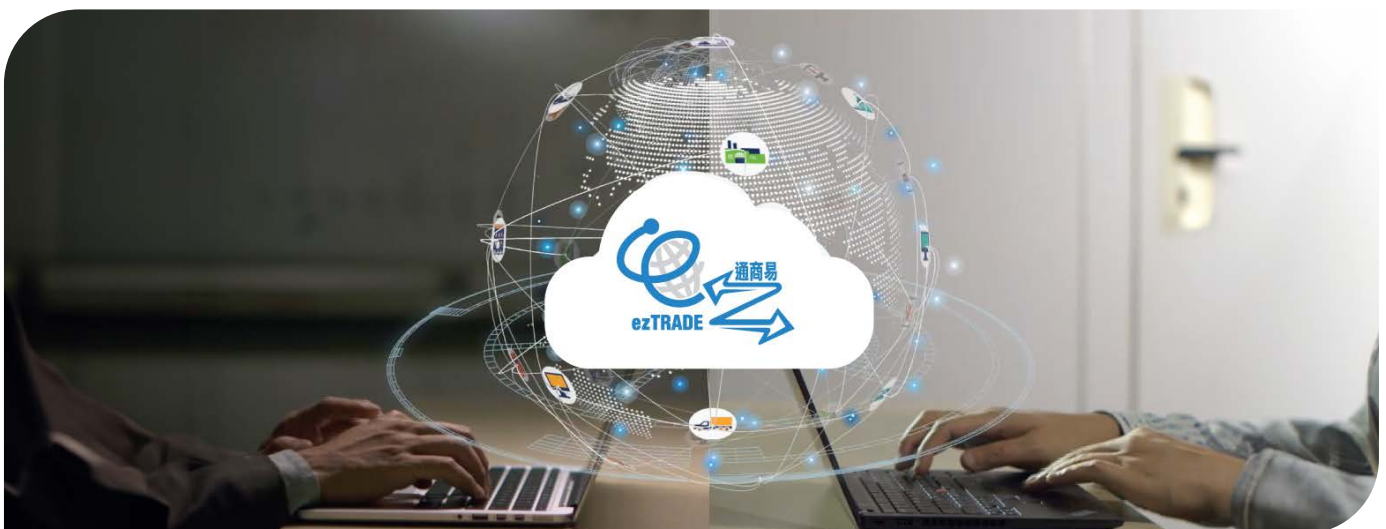

Hong Kong Food and Beverage Industry Advisory Board 香港食品及飲品行業諮詢委員會

The HK Food & Beverage Industry Advisory Board aims to improve the supply chain efficiency for food & beverage industry in Hong Kong, thereby significantly enhancing food safety, improving service, strengthening business & brand sustainability, and positioning Hong Kong at the forefront of F&B supply chain management in Asia.

The 4 workgroups in the Board had steered a range of projects in 2023/24:

Supply Chain Management

Collaborated with Hong Kong Logistics Association (HKLA) and Hong Kong Quality Assurance Agency (HKQAA) and completed the project “Guidelines for application of emerging technologies in cold chain logistics”, which was funded by the government under the Trade and Industrial Organisation Support Fund (TSF).

Technology & Innovations

In 2023/24, site visits to Cianiao automated warehouse and Hong Kong International Airport were arranged.

Omni-channel

The workgroup continued to focus on the initiative of 2D barcode migration together with the GS1 HK 1QR platform, sharing implementation guidelines, checklists, tool kits, use cases, etc. to help local stakeholders on the 2D adoption journey.

Public Policy

The workgroup contributed ideas on a few key topics, including the handling of Styrofoam box largely used by Hong Kong stakeholders for fresh produces, food waste, and Producer Responsibility Scheme on plastic beverage containers (PPRS).

供應鏈管理

GS1 HK與香港物流協會和香港品質保證局合作，完成了由工商機構支援基金撥款資助的《冷鏈物流管理體系之實務守則》項目。

科技和創新

小組在2023/24年期間實地考察了菜鳥智能自動倉庫及香港國際機場。

連結線上線下渠道

工作小組繼續推進2D條碼及GS1 HK 1QR平台的廣泛應用，提供實施指南、工作清單、工具包、案例等資訊，支援企業應用2D條碼。

公共政策

小組就多項關鍵項目提供了意見，包括本地持份者大量應用的新鮮食品發泡膠盒的處理、廚餘、塑膠飲料容器生產者責任計劃等。

The HK IoTIAC aims to promote IoT adoption in Hong Kong to uplift the competitiveness of Hong Kong enterprises and create an IoT ecosystem for continuous growth, with three key focuses: thought leadership & best practices, talent development and policy advocacy.

During 2023-24, the inaugural IOT Data Hackathon was organised in collaboration with Cyberport and HKSTP, which had attracted over 80 participating teams and supported by 22 mentors from different professional fields as well as the IoTIAC. A “Meet-the-CXO” event was organised, connecting top-level executives with hackathon winners.

A series of activities were arranged for the member community, such as Google Cloud sharing on latest AI tools and applications, visits to Cainiao HK Smart Gateway Logistics Centre and Hong Kong International Airport.

Consumers are paying greater attention to the sustainability credentials of both brands and retailers, on top of quality shopping experience and digital convenience – the environmental impact of their purchases, where/how are they sourced, nutritional values, etc.

GS1 HK has been helping the retail sector not just enhance consumer engagement and drive efficiencies across the operations, but also support end-to-end supply chain transparency with the use of global standard-based solutions, sharing important information like sustainability commitments and initiatives with the stakeholders.

Transition to 2D barcodes powered by GS1 加速應用加入GS1標準的QR碼

Global Transitions to 2D

- Supported GS1 Global in engaging key industry stakeholders on 2D barcode transition, to which AS Watson Group agreed to endorse as a signatory of a Global Joint Initiative to have retail POS scanners globally capable of reading and processing both old and new barcodes by the end of 2027.

全球二維碼轉型

- 本會配合GS1全球總部，與本地持份者交流有關二維碼變革計劃，其中屈臣氏集團同意並簽署全球聯合聲明，支持初步目標讓全球零售POS掃描器能在2027年底前讀取和處理新舊2款條碼。



Local 2D Barcodes Task Force

- A 2D Barcodes Task Force was established in Feb 2024 with key retailers and F&B brands in HK, to drive industry collaboration on 2D barcode migration.
- A phased roadmap is developed to expand the usage of "1QR" platform for retailers' private label or brand owners' products, and to upgrade their POS systems next.
- Implementation guidelines, toolkits, checklists, etc. were shared for brand owners, retailers, solution providers to realise the adoption.

Industry Engagement

- Meetings and workshops were arranged to expedite retail's adoption of "1QR", a QR code built on GS1 Digital Link standard comprising diverse information such as product specifications, incentives, certificates, etc.
- During 2023/24, 1,677 members were conscious of 1QR platform and more than 513,000 visits on 1QR recorded.

- 本會聯同香港主要零售商和餐飲品牌於2024年2月成立了「二維碼工作小組」，推動業界合作、變更到二維碼。
- 制定計劃分段路線圖，先擴大「1QR」平台在零售商自家品牌或品牌商產品的應用，第2階段是升級其POS系統。
- 與持份者分享了實施指南、工具包、清單等以落實應用。

行業拓展

- 透過會員工作坊及會面，鼓勵本地大中小零售商採用「1QR」。「1QR」是建基於GS1 Digital Link標準的QR碼，涵蓋產品規格、優惠、認證等多種資訊。
- 在2023/24年度，共1,677個會員接觸到1QR平台，平台流量逾513,000人次。

These QR Codes enable customers to easily access detailed product information with a simple smartphone scan, empowering them to make more informed purchasing decisions. Eat East, a food retail chain draws on the power of “1QR”, a GS1 next generation 2D barcode, not just to facilitate check-out and product management, but also boost customer engagement, especially for the mobile-savvy young segments.

China Industrial Internet project:

- Co-developed the “China Industrial Internet Identification Service Platform” (“CIIISP”) which connects and interchanges GS1 keys and the Industrial Internet Identification IDs in China
- Pilots were completed with customers’ access to product information, testing report, certificates, and warranty information by scanning the GS1 Digital Link QR Code on the product packaging with their mobile phones
- The project is expected to broaden the traceability capability to more industry domains with the use of “1QR”, ezTRACK and BarcodePlus platforms.

Powering Trust with Product Authentication and Traceability

- Embedded with an internationally patented anti-counterfeit technology, GS1 Hong Kong REAL Barcode/QR Code has become a leading anti-counterfeit solution adopted by a number of leading local retail brands in jewelry, cosmetics, food, consumer electronics accessories, industrial products sectors.
- Including a new adoption in pharmaceutical product to track its supply channels visibility, more than 5 million items are tagged with REAL QR code.

Digital & E-commerce Sharing Sessions

- Over 40 “Go Digital” webinars and workshops were held engaging more than 1,000 participants, either hosted by GS1 Hong Kong or jointly organized with industry leaders like HKTVmall, Carousell, eBay, etc., as well as statutory organisations and industry associations such as HKPC, HKTDC, SME Sustainability Society.
- A new training course focusing on e-commerce operations and distribution management was developed to help delegates tap into e-com opportunities.
- As one of the participating organisations in the Digital Transformation Support Pilot Programmed (DTSP), 4 training seminars / webinars were organised to assist participants to embrace digitalisation with funding support.

- 舉辦了逾40場「Go Digital」網上研討會及工作坊，活動由GS1 HK主辦，或與知名機構如HKTVmall、Carousell、eBay等，或法定組織和行業協會如香港生產力促進局、香港貿易發展局、可持續發展學會等協辦。
- 創建新培訓課程，內容圍繞電子商務營運和配送管理，以幫助學員把握電商機遇。
- 作為數碼轉型支援先導計劃的參與機構之一，我們舉辦4場實體/網絡研討會，協助參與者推進數碼轉型並獲資助。

Consumer Caring Scheme 2023

- GS1 HK's Consumer Caring Scheme had recognised 85 companies for their outstanding performance and practices in pursuing consumer care, of which 63 companies are distinguished for their 5 or more years of commitment.
- The award saw 6 new joiners from manufacturers, brand owners and traders across sectors, demonstrating the significant role of consumer caring strategies for all kinds of companies.

COLLABORATIVE NETWORK POWERS LONG-TERM FOOD SUPPLY SUSTAINABILITY 協同生態推動可持續的食品供應鏈

As the global food supply chain networks become more complex, cover greater distances and involve more suppliers, exposure to risk grows exponentially. It is imperative for companies to enable better upstream and downstream traceability that limit health risk, minimise impacts on operations, and instill confidence in the consumers.

GS1 Hong Kong is committed to uplifting food safety through enabling a smarter, more traceable, sustainable food ecosystem in Hong Kong, with the ultimate goal to shelter consumers from the food risks.

Introducing Quality Food Scheme ESG 全新「優質食品計劃ESG」

- 31 food and food services companies were recognised at the series of “Quality Food Scheme”, in which 17 enterprises were recognised of the new “Quality Food Scheme ESG”, an assessment in accordance with GS1 Global Traceability Standard (GTS), MSCI ESG Indexes and United Nations’ Sustainable Development Goals (UN SDGs), aiming to encourage businesses to not only put efforts in food traceability and safety, but also act on ESG practices.
- Counting in the 16 Diamond Enterprises in “Quality Food Scheme+”, the recognised companies had demonstrated robust risk-control, quality assurance, traceability and food safety measures, which in turn safeguards consumers’ health and build brand reputation.
- 「優質食品計劃」系列共表揚了31間食品及餐飲服務企業，當中有17家獲新增「優質食品計劃ESG」嘉許；計劃參照GS1「全球追溯標準」(GTS)、MSCI ESG指數及聯合國「全球17個永續發展目標」等國際標準進行評審，鼓勵企業在保障食品安全及追溯之餘，更兼顧推動環境、社會和企業管治(ESG)發展。

- Our Smart Professional Service team and Smart Operations solution continue to support the industry to achieve process optimisation and real-time data transparency, with the goal to enhance operation efficiency, minimise food safety risk and food waste.
- A leading chain restaurant group has extended to incorporate real-time temperature and humidity monitoring at various warehouses along the production to ensure food quality, whereas a soy producer also expanded the adoption to safeguard customers' health and support ESG compliance.

- As one of the participating organisations in the Digital Transformation Support Pilot Programme (DTSP), 4 training seminars/webinars were organised to assist SMEs in retail & food sectors understand better the funding programme, which attracted over 100 participants.
- Working together with Hong Kong Logistics Association and HKQAA, we helped facilitate the “Guidelines for Application of Emerging Technologies in Cold Chain Logistics Guidance” Workshop series, and over 100 participants attended the 4 sessions of workshops.
- In addition, we also organised “GS1 HK Buyer Connect” event for retailers to meet & network with food suppliers/sellers, supporting businesses explore new opportunities.

ENABLING SAFE AND EFFICIENT HEALTHCARE THROUGH STANDARDS 透過標準推動安全有效的醫療保健

In today's complex healthcare ecosystem, organisations, no matter public or private, must balance demands for improved patient outcomes, operational efficiency, regulatory compliance, and cost control.

GS1 HK has played a pivotal role in optimising healthcare supply chains, enhancing traceability, and strengthening patient safety, which ensures the accurate delivery of the right healthcare supplies to the right patients for the right procedures, supporting the development of a connected, collaborative and innovative healthcare ecosystem.

Tender Requirement of GS1 DataMatrix on Drug Packaging 藥品包裝上更應泛應用GS1 DataMatrix

- GS1 Hong Kong has been actively engaging Hospital Authority and industry stakeholders to promote the adoption of GS1 DataMatrix (2D barcode) on drug packaging, mostly through workshops.
- The administration confirmed to incorporate such requirement in the upcoming new tender with effect from Aug 2024.
- The medical products are required to be labelled in such a way as to facilitate the transfer of product identification information (GTIN), the expiration date/ the best before date, and the batch/lot number from the product to the tracking system at Sales Pack Level.
- GS1 HK積極與醫院管理局及持份者合作，推動在藥物包裝上採用GS1 DataMatrix，包括舉辦多場有關應用GS1 DataMatrix二維碼的培訓工作坊。
- 局方於2024年8月確認在藥品採購的招標書中加入相關要求。
- 醫藥產品需在其銷售包裝上有著產品識別編號 (GTIN)、有效日期/最佳使用日期以及批次編號，以便將這些資訊記錄到追蹤系統內。

Improves Medication Traceability & Safety with GS1 DataMatrix 提升藥品追蹤溯源及安全 符合監管要求

MSD included a unique serial number in the GS1 DataMatrix in addition to the required attributes (GTIN, expiration date and lot number), helping pharmacists to easily check and detect any anomalies on each individual pack, like expired product, when it is dispensed to the patient.

MSD在GS1 DataMatrix中除了基本必須的資料(GTIN、有效日期和批號)外，還加入了獨有序號，以方便藥劑師向病人發放每盒藥物時，輕易地檢驗出任何異常情況，如產品過期等。



Industry Trainings and Advocacy 業界培訓及倡議

- Three workshops on “Unique Device Identification (UDI) for Medical Devices” and customised corporate training had been conducted throughout the year
- Joined forces with HKAPI (Hong Kong Association of the Pharmaceutical Industry) and submitted a recommendation paper to the Department of Health, proposing the inclusion of Global Trade Item Number (GTIN) and Authorised Sellers of Poisons Reference Number (ASP#) in the data structure of the Computerised Transaction Record System (CTR) for Anti-Microbial Resistance (AMR), to enhance traceability and streamline regulatory functions.

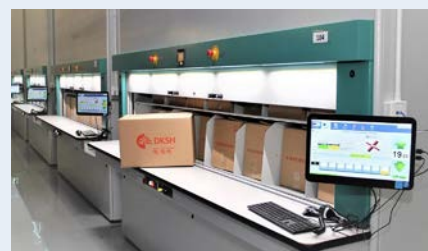

FACILITATING AN EFFICIENT, CONNECTED SMART LOGISTICS NETWORK

促進高效互聯的智能物流網絡

Despite the continued growth of cross-border trade and e-commerce activities in the region, especially of the Greater Bay Area markets, Hong Kong's transport and logistics sector must contend with bottlenecks like rising costs, geo-political tensions and regulatory compliance, last-mile deliveries, and consumers' demand for sustainable practices and the need for end-to-end visibility.

Supply chain visibility is essential for gaining clear insights into a product's journey through the supply chain, empowering companies to manage complex multi-modal deliveries. GS1 Hong Kong has been utilizing a wide range of GS1 standards and solutions to enable the efficient, secure flow of products, capital and information, enhancing efficiencies in logistics and sustainability, as well as better warehouse, transport and asset management.

儘管區內跨境貿易和電商活動持續增長，特別是大灣區市場，但香港的運輸和物流行業仍需面對成本上漲、地緣政治緊張局勢和監管合規、最後一里配送等難題，以至消費者要求可持續營商手法及點到點透明度等所帶來的挑戰。

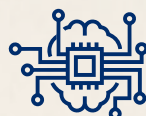

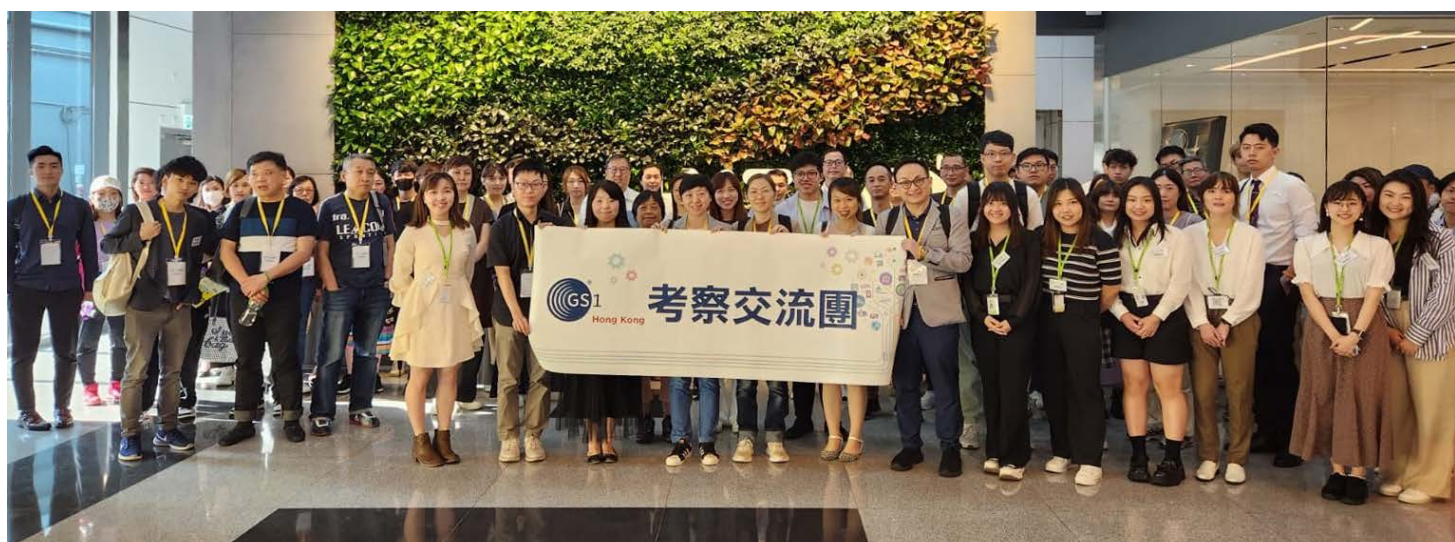
