



Barcode

條碼

A barcode (technically called "GTIN" or "Global Trade Item Number") is a number represented in vertical lines of varying widths printed on labels to uniquely identify items enabling the rapid and un-ambiguous identification of products, assets, documents to people using a scanner. 條碼(亦即GTIN或全球貿易貨品編碼)是一個由不同闊度的垂直線所代表,並印在標籤上用作識別貨件的編碼。透過掃瞄條碼,人們能夠迅速及準確地識別任何貨品、資產、文件和個人身份。

An Electronic Product Code Information Services (EPCIS) standard-based, globalised track and trace platform that enables real-time visibility of goods and information from the production floor and warehouse via logistics to retail shops. Manufacturers, logistic providers and retailers are able to track and trace real-time information from manufacturing to the consumer.

A new standard enables web developers to embed standardised and structured product information in web pages so that it is usable by search engines. It enhances the product visibility on the web and product ranking on the search engine and e-commerce platforms.

Industry engagement starts when an industry reaches out to GS1 Hong Kong for assistance in solving a problem or identifying an opportunity. GS1 Hong Kong works with the industry to define its needs and goals around the challenge and to create adoption plans. We believe that it's important to understand how standards are being adopted and used among businesses within their industries. GS1 standards underpin supply chains, reduce costs and deliver exceptional efficiency in many different industries. Our core sectors are omni-channel and e-commerce, food and food services, healthcare, ICT, transport and logistics, as well as retail and apparel.

Convergence of Information and Divergence of Commerce Channels 匯聚資訊及散佈商務渠道

To create a seamless consumer experience in the trend of omni-channel retailing, retailers and brands must have visible, accurate and interconnected information about products at all times. With the growth of e-commerce and mobile technology, consumers are more empowered than ever before and have increasingly high expectations of product information, product availability and buying experience.

By enabling the unique identification and smooth exchange of products and information – from source to consumers – GS1 standards are facilitating the integration of store operations, delivery and inventory management to fulfil consumers' expectations.

在全渠道零售流行之際,若要創造無縫的消費體驗,零售商和品牌商就必須有任何時候都提供高可視性、準確及有關聯的產品資訊。隨著電子商貿及移動科技不斷發展,消費者不再陷於被動,對產品資訊、貨品供應及購物體驗的要求亦相應提高。

Our Services and Initiatives

1. GS1 SmartSearch

Working collectively with global GS1 members, standards organisations (W3C) and search engine companies to make it easier to discover and describe products on the web, the GS1 SmartSearch project is intended to lay a foundation to make it easier to discover products and understand information about them on the web.

2. REAL Barcode Authentication Solution

"REAL Barcode" is an integrated barcode combining a mark of multiple layers of tamper resistant security features with a GS1 standard barcode, providing high level of security which prevents replication. Through using the mobile app "REAL Barcode", consumers can simply scan the barcode and obtain authentication results within a few seconds.

3. Value+ Product Authentication Solution

A brand protection & consumer engagement solution that appends a unique serialisation number label to allow end-to-end e-Pedigree visibility to bolster consumer confidence and enable personalised post sales engagements.

4. Fast Track Membership Application for E-commerce

In order to facilitate e-Bay merchants to obtain the Global Trade Item Number (GTIN), GS1 Hong Kong provides a fast track for online merchants to complete the membership application 40% faster than normal application.

5. Hong Kong Trusted Product

GS1 Hong Kong works with different e-commerce platforms for listing of Hong Kong Trusted Products. We also provide authorised product barcodes validation service to help consumers make smart purchase decision on-line.

Industry Advisory Boards

1. SMEs Advisory Board

The SMEs Advisory Board was formed in 1999 to help enhance the competitiveness and efficiency of SMEs by driving their adoption of best practices in supply chain management and e-commerce.

2. Electronic Commerce Users' Committee

The Electronic Commerce Users' Committee, with the composition of ezTRADE users, was set up in 1999 to monitor ezTRADE service including service quality and enhancements and promote the use of electronic commerce in Hong Kong.

Increase food safety and consumer confidence through Consumer Connect, a direct mobile communications platform for brand owners to provide trusted product information to consumers.

4. Quality Food Traceability Scheme

The Scheme aims to recognise enterprises that demonstrate excellence in food traceability practices, including the effective adoption of international standards and technology for its food management systems with the ultimate goal in serving better and safer food to consumers.

5. Food Traceability Training Workshop

The Workshop helps enterprises enhance food safety and traceability through global traceability standards, technologies and implementation of strategies.

6. Food Safety Forum

This annual Forum aims to bring together the collective wisdom of industry experts and practitioners to drive effective adoption of international standards and technology for food management systems to improve food traceability practices with the ultimate goal of serving better and safer food to consumers.

7. "Capability Building on Product Data Management for Food SMEs" Project

Organised by the International Food Safety Association, implemented by GS1 Hong Kong and funded by the SME Development Fund of the Trade and Industry Department, HKSAR Government, the Project aims to provide best practices, guidelines and knowledge on managing data to food SMEs through a series of seminars and a Best Practice Special Issue.

Healthcare systems around the globe are facing challenges that affect the entire supply chain, from pharmaceutical to medical device suppliers, manufacturers, wholesalers, distributors, group purchasing organisations and healthcare service providers. Also, the regulatory landscape continues to evolve and new regulations make further impact on the healthcare supply chain. GS1 Hong Kong is committed to enabling the local healthcare sector to implement global standards to create a more efficient and cohesive supply chain with the objectives of enhancing patient safety, achieving greater regulatory compliance and increasing operational efficiency.

Our Services and Initiatives

1. ezTRADE

A standard-based platform that facilitates paperless pharmaceutical procurement process such as order automation. Hong Kong Hospital Authority (HA) started using ezTRADE in 1996. Supply Chain Modernisation project was implemented by HA in 2010 after that encompasses seven clusters of 42 public hospitals and clinics under HA implemented the project in 2014. With 88% of its pharmaceutical orders automated, HA has experienced higher efficiency and consistency in its supply-chain operations, from product orders to physical receipt of the items procured.

2. Cold Chain Management Solution

Achieve real-time traceability and visibility of pharmaceutical products through Cold Chain Management Solution with RFID technology.

3. Healthcare Supply Chain Management Training

The training covers the benefits of implementing global traceability standards in healthcare products and processes, shares tactics in adopting standards and enabling technologies across the entire supply chain to tackle the diversified healthcare challenges.

4. Unique Device Identification

In 2013, The U.S. Food and Drug Administration (FDA) accredited GS1 as issuing agency for Unique Device Identifiers (UDIs). UDIs aim at creating a common worldwide system for product identification that will improve healthcare business processes and patient safety. Healthcare manufacturers in the U.S and around the world can create and maintain a compliant UDI number (i.e. GTIN) by following the requirements of the U.S. FDA UDI Rule and the GS1 General Specifications.

5. GS1 Signed a New Collaborative Agreement with International Health Terminology Standards Development Organization (IHTSDO)

GS1 also has signed a new collaborative agreement with International Health Terminology Standards Development Organization (IHTSDO) that supports the interoperability in health information systems globally. This new agreement focuses on concrete projects to facilitate the linkage between GS1's GTIN and IHTSDO's SNOMED CT global standard, which ensures semantically accurate clinical terminology for consistent use across health systems and services.

我們的服務與舉措

1. 通商易

以GS1標準為基礎所研發的「通商易」平台,有助促進無紙化藥物採購過程,如採購訂單自動化。香港醫管局由 1996年開始採用此服務,其後於2010年推行供應鏈現代化計劃,整項計劃於2014年在七大聯網的42家醫院全面落實。88%的訂單已經自動化,從落訂到接收實物藥品的整個供應鏈均更有效率和劃一。

2. 冷凍鏈管理方案

以RFID科技為基礎的冷凍鏈管理方案,有助醫療機構提升藥物供應鏈的實時源頭可追溯性及透明度。

3. 醫療供應鏈管理工作坊

醫療供應鏈管理工作坊工作坊涵蓋在醫療護理產品和流程中採納全球可追溯性標準的益處,分享在整個供應鏈採納標準和應用技術的策略,以應付種種醫療護理上的挑戰。

4. 醫療器材獨有識別

2013年,GS1獲美國食品藥品監督管理局(FDA)委任為醫療器材獨有識別(UDIs)的簽發機構。醫療器材獨有識別系統為提供全球統一的產品識別而設,以改善醫療護理的程序及病人安全。美國及全球的醫療護理製造商可以依照新美國食品藥品監督 管理局的規例及GS1通用規範,製造及持續使用UDI代碼。

5. GS1 與國際衛生術語標準制定組織 (IHTSDO) 簽訂新的協議

GS1與國際衛生術語標準制定組織(IHTSDO)簽訂了新的協議,讓雙方的健康資訊系統於全球互通。新的協議主要協助建立GS1全球貿易貨品編碼(GTIN)及IHTSDO全球標準 SNOMED CT間的聯繫,幫助醫療系統及服務能使用更精確定義的臨床醫療術語。


